Terms and Conditions of Auction:-

- a) The bidder(s) shall bring their original CNIC at the time of auction, otherwise shall not be allowed to participate in bidding. Intended bidders shall deposit refundable cash of Rs.3,000/- against motorcycle and Rs. 20,000/- against each vehicle to the Officer Incharge or Cashier of the respective Bench Registry/Principal Seat.
- b) Highest bidder will deposit 50% of the bid amount on the spot.
- c) On acceptance of the bid, the bidder will be required to pay the balance amount within seven (07) days.
- d) In case of failure in depositing the balance amount within prescribed time limit, the advance payment of the successful bidder shall be forfeited.
- e) Payment of out-standing token tax (if any) shall be the responsibility of the successful bidder.
- f) All the Government taxes (whatever applicable) will be borne by the successful bidder.
- g) Documents/Registration Books/Cards of the vehicles shall only be delivered after completion of payment and other codal requirements.
- h) The vehicle will be handed over to the buyer after completion of process of transfer of registration of vehicle within 15 days.
