

Note:

1. Only three firms i.e. M/S. Shirazi Trading (Pvt) Ltd, Islamabad, M/S. ZS Traders, Islamabad & M/S. Genius Traders, Islamabad are technically qualified for Tonners/Cartridges.
2. Only three firms are technically qualified for drinking water Bottles i.e. M/S. ZS Traders, Islamabad, M/S. SR Enterprises, Islamabad & M/S. SK Traders, Rawalpindi.
3. Upon evaluation, the samples of following firms were found comparatively better in quality as compared to the samples submitted by other firms which were substandard and of low quality and not meeting the prescribed requirements. Accordingly, the PEC recommends that these items may be procured from the following firms only:

4. On the basis of quality and standard the Broom Stick 500gm Nariel of only two firms i.e. M/S. ZS Traders, Islamabad and M/S. SK Traders, Rawalpindi may be considered. The bids of all other firms for this item may be treated as rejected.
