It is informed with profound grief that Dr. Allama Muhammad Qasim Aini Baloch father of Hon'ble Mr. Justice Muhammad Noor Meskanzai, Chief Justice, Federal Shariat Court of Pakistan has passed away at Islamabad. إِنَّا لِللهِ وَإِنَّا إِلَيْهِ رَاجِعُونَ.

His Namaz-e-Janaza will be offered today on 19th November, 2021 (Friday) at 05:00 p.m in his native town District Kharan-Balochistan.

May Almighty Allah grant him the highest place in Janna'h and give the bereaved family courage to bear this irreparable loss (Ameen).

Dr. Allama Muhammad Qasim Aini Baloch born in the year 1933 in District Kharan-Balochistan. He completed his early education from District Kharan and in the year 1982 did his Ph.D in Islamic Culture/Uloom-ul-Hadees from Jam Shoro University. He served as Lecturer in Atta Shad Degree College, Turbat wherefrom he retired in the year 1992.

He was author of 32 books published in different languages i.e. Arabic, Persian, Urdu, Balochi, Brohi etc. He had good command on poetry in 6 different languages i.e. Arabic, Persian, Urdu, Balochi, Brohi and Pushto.

Late Dr. Allama Muhammad Qasim Aini Baloch is father of Hon'ble Mr. Justice Muhammad Noor Meskanzai, present Chief Justice, Federal Shariat Court of Pakistan/former Chief Justice, Balochistan High Court, Mir Muhammad Azam Meskanzai and Mr. Muhammad Yahya Meskanzai; maternal uncle of Mir Musa Khan Meskanzai; paternal uncle of Molvi Abdul Mutlab; Cousin of Takari Muhammad Naseer, Safar Khan, Ali Nawaz Meskanzai; father in law of Haji Abdul Sattar Dagaarzai, Haji Mumtaz Ahmed Aijbarri; grandfather of Molvi Ubaid Ullah Qambarzai and Muhammad Jan; relative of Mir Ahmed Ali Darazai, Advocate, Mir Liaquat Ali Hotkani, Advocate, Mir Nazir Ahmed Darazai, Mir Aziz Muhammad Meskanzai and Mir Miskan Miskanzai.

Two years before, he had undergone open heart surgery. Due to sudden ailment, he was admitted in Federal Polyclinic Hospital, Islamabad the previous day but could not survive.

He will be buried in his native town Miskan Kallat, District Kharan-Balochistan.
